# **Business Operational Guidelines**

- It is SingHealth's practice to :

    - Evaluated by an appointed cross functional team.
    - Endorsed by approved authorities



# **Business Operational Guidelines**

- SingHealth GPO has a no-gift policy
- Suppliers shall employ fair business practices providing accurate and reliable information.
- Suppliers need to observe protocol in accessing Users :
  - Appointments, with clear objectives of meetings
- Suppliers to conduct themselves in the highest standards of integrity.
